DECLARATION

I/We fully understand the content of this form and accept my/our responsibilities and obligations as follows:

- This application is subject to the horse passing a pre-export veterinary examination. The pre-export veterinary examination will be carried out solely to determine the horse's suitability for export from Hong Kong and is not equivalent to a full pre-purchase veterinary examination. I/We accept that the Veterinary Surgeon's findings are for my/our information only and should not be treated as conclusive.
- I/We am/are responsible for all livery charges incurred from the horse's retirement in Hong Kong until the time of export in addition to the full export charges. All these charges can be settled through my Club account at least one week prior to shipment.
- The horse is exported solely at my/our own risk and responsibility.
- After export, I/we will ensure that adequate veterinary treatment is given whenever necessary and that acceptable stable management and horse welfare practices are maintained at all times whilst the horse remains under my/our ownership.
- I/we understand that I/we may be subject to disciplinary action by the Club if I/we fail to comply with our responsibilities and obligations stated in this form, or otherwise make any false, inaccurate or incomplete declaration in this form.

By submitting the application, I/we agree to allow the Club to use, make available and/or public in Hong Kong or elsewhere via various channels of the Club or any third party authorised by the Club (including websites, social media platforms, publications or other channels like TV or radio programme, as well as any other media now known or invented in the future) all information relating to the horse for the purposes of maintaining and enhancing horse welfare, which shall include without limitation:

- Name of owners and ownership information;
- Horse names, racing colours and other indicia of the horse;
- Horse related data and records including but not limited to form, rating, performance, trackwork and veterinary records and related data, biological data, movement records, pedigree, prize money earned etc.; and
- Horse export information (including, but not limited to, destination, future career, future ownership arrangement etc.)
- Other information which the Club sees fit as part of the horse information available to the public and/or for the administration, promotion or otherwise for the benefit of horse welfare.
