Application for Replacement of the Original Import Permit

I/We, the undersigned, wish to apply to the Stewards of The Hong Kong Jockey Club for a replacement of the original permit under which my/our retired horse is imported. **If my/our application is approved, I/we agree to export my/our retired horse at my/our own cost unless the horse is certified unsuitable for export by the Club's Veterinary Surgeon and has to be humanely put down. I/We also agree to import a replacement horse which satisfies the criteria laid down by the Club for this Replacement Permit.**

I/We understand that my/our retired horse to be replaced must fulfil the following conditions before my/our application can be accepted :-

- It was retired within 18 months upon arrival in the Hong Kong SAR; and
- It did not have more than 1 start in the Hong Kong SAR.

Successful applicant will receive a travel subsidy from the Club up to the import fee paid at time of the arrival of the above retired horse in HK or the actual shipping cost, whichever is lower, when the retired horse is exported to overseas.

D. DECLARATION (If your retired horse has been or will be put down, the following Declarations are not applicable.)

I/We fully understand the contents of this form and accept my/our responsibilities and obligations as follows:

- This application is subject to the horse passing a pre-export veterinary examination. The pre-export veterinary examination will be carried out solely to determine the horse's suitability for export from Hong Kong and is not equivalent to a full pre-purchase veterinary examination. I/We accept that the Veterinary Surgeon's findings are for my/our information only and should not be treated as conclusive.
- I/We am/are responsible for all livery charges incurred from the horse's retirement in Hong Kong until the time of export in addition to the full export charges. All these charges can be settled through my club account at least one week prior to shipment.
- The horse is exported solely at my/our own risk and responsibility.
- After export, I/we will ensure that adequate veterinary treatment is given whenever necessary and that acceptable stable management practices are maintained at all times whilst the horse remains under my/our ownership.
