I hereby declare and agree that:

本人申報、聲明及同意如下:

- I do not have and have not had within 14 days prior to the date of visit any of the common symptoms of Coronavirus Disease 2019 (COVID-19) such as fever, malaise, dry cough, shortness of breath, nasal congestion, headache, conjunctivitis, sore throat, diarrhoea, loss of taste or smell, skin rash or discolouration of fingers or toes 本人現時及在到訪日期前 14 日內並無以下任何 2019 冠狀病毒病的常見病徵: 包括發燒、乏力、乾咳、呼吸困難、鼻塞、頭痛、結膜炎、喉嚨痛、腹瀉、喪失味覺或嗅 覺、皮疹或手指或腳趾變色
- I am not currently subject to any quarantine order issued by the Government.

- I have not been in close contact with any person who has travelled outside Hong Kong and is currently subject to a quarantine order issued by the Government, in particular family members, helpers or drivers;
 - 本人並未曾與任何曾離開香港而現時受政府發出的檢疫令管限的任何人士有密切接觸,尤其是家人、家庭傭工及司機。
- I have not been in close contact with any person who is a confirmed or preliminary positive case of COVID-19 infection in Hong Kong or overseas within 14 days prior to the date of visit.

- I am not required to undergo COVID-19 testing pursuant to a compulsory testing notice or direction / I have undergone COVID-19 testing pursuant to a compulsory testing notice or direction and the result is negative.

"Close contact" generally means having direct physical contact, living in the same household, travelling in the same vehicle or flight, having social contact in close proximity such as dining together. The above examples are not exhaustive.
