Terms & Conditions

- 1. By enrolling and participating in the event, you are deemed to have read and agreed to the following Terms and Conditions. Participation in the event is subject to the rules and Bye-laws of The Hong Kong Jockey Club (the "Club") and the membership privileges of the respective membership category.
- 2. Enrolment is only open to Members.
- 3. Each Membership account can register maximum of 2 participants for each session. Each Membership account may only register at most for one session on each race day.
- 4. Each session of the event is subject to limited quotas. Reservation will be allotted on a first-come, first-served basis. If the event is full, the enrolment will be put on a waiting list on a first-come, first-served basis according to the time of enrolment.
- 5. Participants must be aged 18 or above.
- 6. After the enrollment process, Member can view the enrolment result via the Members' Mobile App and will not receive a confirmation email. An enrolment once submitted cannot be cancelled or amended, except for cancellation at or before 3pm at least 4 days in advance of the event date. A cancellation/no show charge of \$200 per person will be applied if a Member cancels the enrolment after the deadline or no show.
- 7. The Member submitting the enrolment must attend the relevant session of the event in person, and accompany his/her guest participating in the session at all times. An enrolled session is not transferrable and cannot be exchanged. If a Member or his/her guests fails to report for the relevant session at the designated time, the relevant place in the enrollment will be forfeited by the Club and allocated to other participants, subject to the relevant no show charge.
- 8. The Club may take photos and videos of Members and their guests participating in the event and may use such images and videos for promotional and/or record purposes, where Members and their guests may be identified. In case of any objection, please notify the Club in writing.
- 9. Members shall, and shall ensure that their guests will, comply with these Terms and Conditions, the rules and conditions for using the relevant facilities, as well as follow the instructions of staff onsite. Participants must take care of and be responsible for their own personal belongings and safety. To the maximum extent permitted by laws of Hong Kong, the Club will not be held responsible for any loss or damage to property, nor for any injuries or deaths sustained by any participants. - 10. The event will not take place if the race meeting on the event date is cancelled. No replacement session will be provided for a cancelled session.
