Terms & Conditions

 - For event on 15 January 2025: 8 January 2025
 - For event on 22 January 2025: 13 January 2025
5. If the event is full, the reservations will be put on a waiting list on a first-come, first-served basis according to the reservation time.
6. A late cancellation or no-show charge of HK\$500 per head will be applied if you:
 - Cancel your reservation after the cancellation cut-off time:
 - For event on 8 January 2025: 3pm on 3 January 2025 (Friday)
 - For event on 15 January 2025: 3pm on 10 January 2025 (Friday)
 - For event on 22 January 2025: 3pm on 17 January 2025 (Friday)
 - Actual attendance is less than seats reserved
 - No show on the event day
7. Please inform The Hong Kong Jockey Club of any food allergies at least seven working days prior to the event. The Hong Kong Jockey Club will not be responsible for any symptoms or conditions that may develop caused by an allergic reaction to any food or drinks served and consumed.
